



Oakwood Arts for the Spirit Program is currently seeking DSWPS artwork for a group show: 2D or 3D of any media that helps create a peaceful, restorative and healing environment. No entry fee - 30% commission for sales. Purchases go thru Oakwood ATF.

## Entries to Jackie Rybinski - Details below. Deadline is June 20.

Acceptance notification in July. Install in August(?) Shows are up 12 weeks. Accepted work will be marketed on their web page: Oakwood Arts for the Spirit, www.Oakwood.org.

Send up to 3 pieces of art on digital file (jpeg only, 300dpi sized to 3x5"). Please name each file with your last name and number each file, ex: rybinski#1, rybinski#2.

Send to jackierybinski@comcast.net. Send your file as an attachment to your email to Jackie. Include your name & phone number with numbered titles, prices & sizes in your e-mail message.

- 2-D exhibit gallery panels measure 42" high and 45" to 94" wide
- 3-D exhibit display cases range in size from 17"w 17"h 17"d to 17"w 17"h 36"d (for fragile works)

Accepted work: 2-D works must be framed in a professional manner. **Nielsen type** metal frames with standard 3/8" open back channels or **Wood frames** at least 3/4" wide are acceptable.

**Clip-on frames are not acceptable.** Unframed, stretched canvases are acceptable with a painted or finished edge.

## 'Then and Now' at the Detroit Historical Museum

I hope everyone has been able to see the exhibit or has plans to before the closing date, July 6. This historic exhibit would not have been possible without the input of several volunteers. I want

to thank *Lily Dudgeon* for approaching the DHM and initiating this exhibit.

She also loaned some of her personal material. I know she would have loved to been part of the planning and development, but illness prevented more from *Lily*.

I especially want to thank *Julie Sabit* for her invaluable guidance and <u>enthusiasm</u>. She loaned her copy of our first 50 years history book and directed me to the Burton Collection at the Detroit Public Library, which sent me on a terrific hunt.

It was quite an experience to pick up our 1903 recording secretary's book and read the minutes of that first meeting in Eleanor Candler's own handwriting. Photographs of old Detroit art buildings and artists are always a thrill to see. The number of artifacts and photos we could use was unbelievable. The exhibit is a chance to see these historic artifacts before they go back into storage – don't miss it.



Perseverance paid off when a portfolio was opened and there was the much talked about "Thank You" scroll from the WWI French artists for DSWPS charity. It was thought to have been lost by the DIA, but there it was, in a mislabeled file in the Burton Collection. Once the exhibit closes I will see to it that the scroll is labeled properly and added to the index.

Candy Law and Nobuko Yamasaki contributed educational displays that added greatly to the exhibit. Lori Zurvalec's son David edited the VHS tape of a DSWPS show "A Room of Our Own" held at the Grosse Pte. Art Center. His work was much appreciated.

**President's Communication**: President Camilleri thanked Jackie Rybinski and all those who helped Jackie to put together the exhibit at the Detroit Historical Museum .

On behalf of the entire membership Nicole expressed sympathy to Kathy O'Connell and Janet Kondziela on the fire that devastated their shared studio.

Nicole welcomed and congratulated Laura Hidalgo, our 2014 scholarship recipient. New member Ruth Harvey was introduced.

Nicole thanked the membership for the opportunity to represent DSWPS as president for the past two years.

Corresponding Secretary Joyce Manke: The newsletter for June is in progress.

Treasurer Bette Prudden reported an April starting balance and an ending balance.

First VP Deb Maiale reported that the September 18, 2014 meeting would be held at the Detroit Yacht Club.

**Second VP Exhibitions Kathy O'Connell** reported that there is as yet no chairperson for the Arts for the Spirit exhibition. This person will receive all the digital images and put them on one disk which will be submitted to Oakwood for jurying. There will be a 30% commission on sold work.
